

HIGHLIGHTS – IMPAIRED DRIVING

- Increase the number of Traffic Safety Resource Prosecutors (TSRPs) from 1 to 3
- Add Electronic Home Monitoring in Clark County
- DUI Court monitoring Mothers Against Drunk Driving (MADD) Project
- Grant with Administrative Office of the Courts (AOC) to manage the DUI Court program, additional courts, increased funding for some existing courts
- Support for Driver Alcohol Detective Systems for Safety (DADSS)
- Dedicated enforcement in Tacoma & Yakima

Impaired	\$6,802,197	\$4,992,000	+\$1,810,197



HIGHLIGHTS – OCCUPANT PROTECTION

- Additional funding for Child Protective Seat (CPS) program administration
- Additional funding for CPS Technician mini-grants & training
- Positive Community Norms project continuing no budget change

Occ. Prot.	\$1,596,000	\$1,395,000	+\$201,000



HIGHLIGHTS – YOUNG DRIVER SAFETY

- Increase funds for Teens In The Driver Seat school-based program
- New campaign on "Next-level Traffic Safety Education Media Campaign" (contingent on legislation)
- Teen Target Zero continue no funding change
- Vehicle Safety Technology Education for Driving Instructors continue no budget change
- Continue the "Most Steer Clear" (in the Impaired Driving Program)
- Continue the Transforming Traffic Safety Culture with PCN (in the Occupant Protection program)

Young Driver	\$480,000	\$260,000	+\$220,000



HIGHLIGHTS – WALKER & ROLLER SAFETY

- FFFY24 adds 3 new projects & continue a major statewide media campaign
- Continue: Lewis and Cowlitz County Walker Roller Equity Project
- New Projects:
 - Seattle Neighborhood Greenways Walker Roller Safety Community Engagement & Education Program Manager
 - Good to Go! Edmonds
 - Tacoma Neighborhood Education Project

Walker & Roller Safety	\$1,175,000	\$1,156,758	+\$18,242



HIGHLIGHTS – DISTRACTED DRIVING (DD)

- Continue the King County Distracted Driving Campaign, Commercial Driver Training (TREDS) & Employer Toolkit
- Eliminate DD Symposium/Training

Program	FFY2024	FFY2023	Difference
Distracted Driving	\$1,082,000	\$1,160,000	-\$78,000



HIGHLIGHTS – TRIBAL TRAFFIC SAFETY

 Increase funds to support three tribal traffic safety coordinators – only 1 in the Yakama nation currently

Program	FFY2024	FFY2023	Difference
Tribal Traffic Safety	\$400,000	\$240,000	+\$160,000



HIGHLIGHTS – MOTORCYCLE SAFETY

- Continue with countermeasures to address rider education, High Visibility Enforcement (HVE) & motorist awareness
- Continue the rebrand of the motorcycle campaign no change in budget

Program	FFY2024	FFY2023	Difference
Motorcycle Safety	\$1,440,000	\$900,000	+\$540,000



HIGHLIGHTS - COMMUNICATION

- Increase funds for website redesign
- Increase funds for impaired driving HVE media all other HVE media static
- New Speed Media Campaign
- Additional funds for "Together We Get There" campaign
- Increase funds for local Target Zero Managers (TZM) media projects & TZM Communications Lead
- New funding for expanded community engagement & outreach

Program	FFY2024	FFY2023	Difference
Communications W/HVE Media	\$5,150,000	\$1,870,000	+\$3,280,000
Communications W/O HVE Media	\$2,550,000	\$1,870,000	+\$680,000



HIGHLIGHTS – TRAFFIC RECORDS

- All single year projects ending in 2023
- Success in spending down a surplus
- No new projects all FY24 projects are existing multi-year projects

Program	FFY2024	FFY2023	Difference
Traffic Records	\$1,611,831	\$2,005,349	(\$393,518)



HIGHLIGHTS – RESEARCH & DATA

- I project ending (DOH Emerg. Dept. linkages for AIAN)
- 1 project continuing (UW High Risk Drivers)
- 3 new projects
 - WSU Drug Recognition Expert (DRE) Research
 - Yakima DUI Court Evaluation
 - UW eScooter Injuries Research

Research & Data	\$867,264	\$572,820	+\$294,444



HIGHLIGHTS – COMMUNITY TRAFFIC SERVICES

- Increase compensation for Target Zero Managers as part of the program update
- All HVE has been moved to this program plan
- 2 new projects:
 - Rural Trauma Team Development Courses
 - Science of Positive for Rural Populations

Comm Traffic Serv W/O HVE	\$3,296,457	\$1,741,000	+\$1,555,457



HIGHLIGHTS – SPEED PROGRAM

- New program plan
- New projects:
 - Speed Program Readiness and GHSA Consultation
 - Regional and/or Statewide Stakeholder Engagement
 - Speeding in school zone study participant support
 - Community speed management education & resource guide development
