Small Group Break Out Notes

Group 1: Charlotte:

1. Message to drivers to drive the speed that's right for the conditions, or the limit, whichever is lower
2. Message to drivers to be courteous and not be aggressive, have patience, show how the don't benefit that much by being rude
3. Message to drivers to put the phone away, use an app to teach you an easy way to set for driving mode

4. Message to pedestrians to use the crosswalk to activate a signal and make eye contact with drivers

Group 2: David

1. General consensus was that social media would be the most cost-effective way to disseminate message. Messages can be tailored to specific groups and/or geographic areas. Messages are also trackable.

Group 3: Carr

- Message to drivers about timing and visibility – Daylight savings and dark months and hours are more dangerous, students walking to school
- Message to pedestrians and rollers of being seen (be aware of implicit ableism)
- Awareness of vulnerable user laws, reminders of cross walk safety. We all care for each other and safe driving is a big part of that.

Group 4: Scott

- Individuals with disabilities can choose to be in the roadway because the sidewalk is impassable - be courteous, they are trying to be safe
- Focusing on egregious driver behaviors and the fact that there should be more positive traffic safety culture...benefits to everyone from that
- Focus on struck from behind and failure to yield behaviors - both are increased in 2020 from 2019
- Avoid pedestrian shaming

Group 5: Erica

- Drivers to follow speed limit
- Actively look and scan at turns or through intersection
- Awareness of your vehicle size – give space as you pass
- Awareness of how dangerous it is to drive a vehicle
