  - c) Graduated Fines Structure (income adjusted?)
  - d) Equity as stand-alone topic
  - e) Speed and Land Use / Speed and Target Zero (including safety planning that relates to speed and active transpo think more long term)
  - f) Sidewalk Data and Accessibility (relates to a previous rec; individual delivery devices Kirkland has a moratorium on sidewalk use)

- h) Hit and Run / Near Miss esp. for BIPOC and marginalized populations. How/if they are disproportionally impacted by near-miss and hit-and-run? Identifying questions and data needs, potential funding, behavioral change thru positive community norms. Location of cameras that catch near misses? Do people call them in? Who, to where? What does LE do with that info? Current data gaps.
