1) Intro and Welcome, Jessie Knudsen, WTSC Program Manager

Established a quorum is present.

Reviewed June 2022 ATSC meeting minutes. The minutes were approved as presented.

2) Membership Updates

Katharine Miller (Spokane traffic engineer) and Walt Bowen (WA senior citizen lobby) are stepping down from ATSC.

We are actively recruiting ATSC members to fill geographical and representation gaps. Map (see image below) identifies current representation on ATSC. Dark blue regions are where there is currently no representation, light blue areas have one representative, and green areas have more than two representatives serving on ATSC.



Representation needed on ATSC include Association of Counties, law enforcement, houseless community.

Request of ATSC members – Send recommendations of individuals that may fill the representation gaps to Pat Hughes or Jessie Knudsen by July 31. WTSC is seeking volunteers to serve on their PEAR (pro-equity anti-racism) committee. Contact Jessie Knudsen or Mark McKechnie if you're interested.

3) CJATS Funding, Jessie Knudsen

Proposal to send to OFM to use the CJATS funding. Proposal is due August 1, and funding must be spent by June 30, 2023.

- We will fill the gaps (identified by WSDOT) to address small, overburdened jurisdictions who lack technical and staff capacity to complete an ADA transition plan, and may have outdated, incomplete, or non-existent Active Transportation plans.
- Fund a contractor to deliver report.
- Main deliverables of the report are to: develop a model to show how to integrate the two plans, generate findings to identify jurisdictions as good partners and the unique needs of communities for assistance.
- If funding allows after tech assistance and training supplied, contractor can identify grants and other funds to help jurisdictions make the necessary changes.
- Goal: all jurisdictions identified in the report have integrated ADA and Active Transportation transition plans.
