Super Bowl Messaging Resources

Consider incorporating these <u>free traffic safety resources</u> in your organizational communications in anticipation of the Super Bowl to discourage impaired driving. Impaired driving risks are often compounded by speeding and in the past decade in WA State, 66% of fatal impaired driverinvolved crashes also had a speeding-driver involved. High speeds increase the severity of injuries and reduce the likelihood of survival for people involved in a crash. Thanks for helping underscore the importance of sober drivers who safely manage their traveling speed!

• Facilitate guided networking among participants from different sectors to help break down barriers and facilitate future collaboration.

• Provide ideas, resources, inspiration and opportunity to collaboratively develop strategies to our attendees to encourage them to take actions to advance a safe system approach in their communities when they go home.

• Provide actionable information through interactive workshops and other engaging formats to help attendees build the skills and knowledge necessary to improve their ability to perform the work of creating a safer transportation system.

Webinar: <u>An overview of FHWA's Separated Bike Lanes on Higher Speed Roadways: A</u> <u>Toolkit and Guide</u>

Includes policies, processes, and other resources and procedures that can help agencies overcome the obstacles limiting them from implementing separated bicycle lanes where they are needed most, on higher speed roads like arterials.

Webinar: Planning for Walkability is Planning for Health

Learn some of the latest research on how walkability affects health. Hear about the elements of land use and street design that lead to people walking more, and what that means for addressing chronic disease. Discover research on health impacts to influence regional and local transportation planning and within public health.

Webinar: Setting Speeds for Health and Safety

Twenty miles per hour (mph) speed limits are promoted for public health and safety because they help ensure that vehicle crashes are less common and more survivable when they occur. This webinar will look at state laws and city efforts that support slower speed limits and managing speed for safety. By highlighting laws that define city authority and how cities can use that authority this webinar provides a holistic picture of speed limit reform.
