
Canyon Road Emphasis

With a <u>reputation for dangerous driving involving speeding</u>, Canyon Road in Pierce County has become known as "Canyon Road Speedway" or "Death Trap Canyon Road." In February, the Pierce County Sheriff's Office (PCSO) coordinated a Canyon Road Emphasis that resulted in great success.

A big thanks goes to Lt. Kadow and Sgt. Darby with PCSO for their leadership and direction for this emphasis, as well as the many agencies that participated: Bonney Lake PD (38 hours), Fife PD (34.5 hours), Gig Harbor PD (32 hours), Lakewood PD (32 hours), Pierce County Sheriff's Office (147.25 hours), Puyallup PD (30.5 hours), Ruston PD (24 hours), Sumner PD (54.5 hours), and Tacoma PD (83.5 hours).

Special recognition goes to the Pierce County Sheriff's Office Public Information Officer, Deputy Cappetto, for outstanding work in public outreach during this campaign, as both the <u>initial</u>

<u>crackdown video</u> and the <u>subsequent update video</u> amassed a total engagement reach of 302,253 interactions across multiple social media platforms. View the final Canyon Emphasis Stats video here.



Highlights:

Numerous infractions were issued to violators exceeding 20+ mph over the speed limit.

Arrests were made for racing.

Several vehicles fled from officers at reckless speeds but were not pursued due to traffic conditions.

Anecdotally, speeds in the area significantly decreased as the emphasis progressed.

New WTSC Brief: Traffic Safety Enforcement Case Filings

The <u>Traffic Safety Enforcement Case Filings brief</u> includes 5 years of traffic-safety related case filings from the Administrative Office of the Courts, shown by year and month, for impaired driving, distracted driving, speeding, and restraint use violations. This is a handy quick reference to see the trend of case filings over time.

Vehicle Safety Recalls Week: March 3-9

NHTSA's annual Vehicle Safety Recalls Week starts today. During this time, vehicle owners are encouraged to check for recalls through NHTSA's <u>recall lookup tool</u>. The lookup tool results will yield information about safety recalls, investigations, complaints, and manufacturer communication.

Interested in going digital? NHTSA also offers the <u>SaferCar App</u>, which allows users to track recall information for vehicles, car seats, tires, and other equipment all in one place.
