



Washington Victim Impact Panel Registry

*Last updated March 1 2021

In the 2011 legislative session, HB 1789 set forth minimum requirements for Victim Impact Panels and asked the Washington Traffic Safety Commission (WTSC) to maintain a registry of qualified Victim Impact Panels. This registry lists those VIPs who have certified that they meet the minimum requirements. This registry and other information is available online at <http://wtsc.wa.gov/victim-impact-panels/>.

Register New Panels or Update Registry Information: WTSC will update this registry once a year. The Victim Impact Panel Certification Form allows the designated facilitator to certify that their VIP meets minimum requirements. The VIP Update Form allows the designated facilitator to update their panel's information on the registry. All forms received by February 15 will be included in the yearly update on March 1.
